Use Multiple Modalities

E-Reader technology gives students the ability to easily adjust the font size, text color, margins, and number of words on the screen, allowing struggling readers to better access curriculum. Recent studies have shown that this alternative to printed text can be helpful for students with language-based learning disabilities, particularly dyslexia. Below are some available alternative text options. While only some of these programs include the availability of a text reader, they all provide students with the ability to customize the text they read.

<u>Bookshare</u>	Bookshare is an online database of over 500,000 titles, including textbooks and novels. This program allows for text to be read aloud and provides the choice to vary text size, font style, and color. In addition, students can change the amount of words on the page. HOW DOES THIS CONNECT TO USE MULTIPLE MODALITIES?
